4. Forfeiting of EMD: Should the successful bidder failed to furnish security or refuse to execute the work in accordance with his accepted tender, EMD will be forfeited and Board may thereon award the contract to another bidder.
  5. Firm's quoted rate shall be inclusive of all taxes & duties.
  6. Validity of offer should be **03 months** from the date of receipt of the quotations.
  7. The firm shall submit copies of executed work orders in Govt. / Private Firms to prove their experience in executing similar works in the last seven years. Similar works shall mean experience in " Installation of pump sets/pipe lines with associated items (OR) Execution of fabrication works/mechanical maintenance works" .
