Earnest Money of Rs. 3,601/- shall be paid to the Financial Adviser & Chief Accounts Officer/VPT in cash or Bank Draft issued by any nationalized Banks/ Scheduled Banks and No Cheques will be entertained under any circumstances. The E.M.D. paid will not carry any interest. The Earnest Money of unsuccessful Tenderers will be refunded. Bids received without EMD will be summarily rejected.
4. Forfeiting of EMD: Should the successful bidder failed to furnish security or refuse to execute the work in accordance with his accepted tender, EMD will be forfeited and Board may thereon award the contract to another bidder.
5. Firm’s quoted rate shall be inclusive of all taxes & duties except service tax. Service tax will be reimbursed on submission of documentary proof.
6. Validity of offer should be **03 months** from the date of receipt of the quotations.
7. The firm shall submit copies of executed work orders in Govt. / Private Firms to prove their experience in executing similar works in the last seven years. Similar

works shall mean experience in “Civil maintenance works or sewage Treatment Plant (STP) maintenance works”

  17. Firm has to mobilize the required tools, tackles, materials (viz. ropes, pulleys, scuff holding, shovels, buckets etc. which are necessary) for completion of the subject work immediately after issue of site clearance for execution of the subject work.
