- 8. The VPT reserves the right to withdraw any item of tender or to cancel the subject tender without assigning any reason.
- 9. Statutory deductions will be made from the bills.
- 10. Payment will be made after completion of the work to the satisfaction of VPT.
- 11. The Standard VPT conditions, which are not mentioned, are also applicable to this work.
- 12. Service tax registration Certificate shall be submitted along with tender. Service tax will be reimbursed against submission of service tax registration number.
