(5) Tender should be submitted in the prescribed proforma duly signed, otherwise the tender will be liable for rejection.

(6) Payment will be made with in one month after receiving the bills in triplicate, with advance stamped receipt.

(7) The Contract will be in force for a period of two years from the date of award of work order and shall be extended if required on consent from the tenderer. During the currency of contract, the accepted rates can not be escalated for any reason and the supplier shall abide for supply of the same as per contract.

(8) The contractor should supply Bread in the morning by 7-00A.M. and Bun in the evening by 3.00 P.M. to G.J. Hospital, Visakhapatnam, as per the indent given by the Dietician, G.J. Hospital, Visakhapatnam-530 024.
