- 1. The bidder shall have minimum annual turnover of Rs. 1 Lakh for one year and has to submit last three years annual turnover certificate by chartered accountant.**
- 2. The tenderer has to produce the documentary proof in support of supplies made to the port sector/central Government/P.S.U/Corporate Hospital ( old P.O copies should be enclosed)**
- 3. F.D.A certificate copy/Drug License certificate.**
- 4. Sales tax registration (C.S.T/A.P.G.S.T certificate should be enclosed)**
- 5. Terms & Condition of the tender duly signed by tenderer.**
- 6. Submit the cost of tender papers Rs. 200/- by demand draft in favour of F.A & C.A.O, VISAKHAPATNAM PORT TRUST, drawn on STATE BANK OF INDIA, Port Branch, Visakhapatnam.**
- 7. A.Self- declaration Certificate should be submitted by the bidder that he has not been convicted for any offence under drugs and cosmetic act 1940 during the last three years.**
- 8. Samples must be submitted where ever specified along with the quotations. Sample must be carefully packed and labeled clearly with Tender number, subject**

**and Tender's name for easy identification.**

- 1 The Tender should be submitted in a two bid system in a sealed cover by furnishing the price for Sl.no: 1 to 21 suture material, on or before 21-04-2015 at 2.00 pm at C.M.O.'s office of G.J. Hospital/VPT. The technical bid in a separate cover and price bid in a separate should be submitted. If price bid and technical bid are submitted in same cover the tender will be rejected.**
- 2 Quotation should be free from corrections/erasures. Incase there is any unavoidable correction it should be properly attested. If not, the quotation will not be considered.**
- 3 The quotation must be in the form furnished by the port trust . VPT**
- 4 The port trust reserves the right to reject any or all tenders without assigning any reasons thereof and does not bind itself to accept the lowest quotations.**
- 5 The port trust reserves the right to modify the quantity specified in this enquiry.**
- 6 Surgical items/chemicals should have minimum one**

year expiry period, where ever applicable, from the date supply. Preferably fresh stock.

**7 Supply 1<sup>st</sup> installment of ordered quantity i.e., 50% of P.O quantity and remaining stocks should be supplied on confirmation by CMO/VPT basing on the available stocks/consumption.**

**8 You have to submit specify the quoted product in the enclosed Performa like description of item brand name or company name .**

**9 If the tenderer fails to deliver the goods or part there of within the specific delivery period or as the extended delivery period.**

**A) Penalty will be recovered from tenderer @ 0.5% per week upto 10% of the value of the stock not supplied delayed.**

**B)If the tenderer fails to deliver goods according to purchase order. The amount will be recovered from the tenderer @ rate of 18% (risk purchase)**

on the value of the item.

**10** Any increase in Taxes and Duties after expiry of the contractual delivery period or during the extended delivery period is not admissible.
