Bank Draft issued by any nationalized Banks / Scheduled Banks. **Micro & Small Enterprises registered with NSIC & Ministry of MSME with adequate monitory limits are exempted from the payment of TD & EMD amount for participating in VPT tenders for the execution of works / AMC Works / Service Contracts etc. (i.e., exemptions from payment of EMD and TD cost, whose monitory limits are more than the estimate value of the respective purchase tenders)** No Cheques will be entertained under any circumstances.
