Criteria:

Terms and conditions:

1. Firm who are willing to participate in the tender shall have the previous experience in execution of the similar works i.e., Rewinding and reconditioning of 400 & 250KVA and above Transformers and firm should submit the proof of the same along with their tender.
2. The Tenders must be sent in one cover containing two separate covers and these two covers shall be super scribed as "Cover-I and Cover-II" respectively.

All the covers shall be addressed to Supdt. Engineer (Elec), Visakhapatnam Port Trust, Visakhapatnam - 530 035 and sealed properly. Names and addresses of the tenderer shall also be written on all the covers.

The tenderer shall clearly write on Cover-I (Technical Bid) - Tender for the work of "Rewinding and reconditioning of 400 / 250KVA Transformers ".

On Cover-II (Price Bid) - Tender for the Work of "Rewinding and reconditioning of 400/250 KVA Transformers"

The main cover containing Cover-I, Cover-II along with the attached cover containing EMD shall reach Supdt. Engineer (Elec), Visakhapatnam Port Trust, Visakhapatnam - 530 035 within the schedule date and time.

3. Firm's quoted rate shall be inclusive of all taxes & duties except Service Tax.
4. Service Tax will be paid extra on submission of documentary evidence.
5. Validity of offer should be 03 months from the last date of receipt of the offers.
6. Statutory deductions will be made from the bills.
7. Conditional offers will be rejected.

9. The workmanship and materials used in this work shall be guaranteed for a period of 12 months from the date of completion of the work.

11. The work shall be completed within the stipulated period, failing which a penalty @ ½% will be levied for every week of delay, on the part of the contractor subject to maximum 10% on total contract / executed value.
