Sub: - Repairs to 03nos Yokohama Fenders of VPT – Reg.

This is to kindly inform that VPT has 07nos Yokohama Fenders to carry out Ship to Ship cargo operations. Of these 07 nos Yokohama Fenders 03 nos fenders need to be repaired due to wear and tear. Therefore it is requested to upload the following in the VPT website.

Scope of Work : - It is proposed to call for tenders for the repairs to the 03 nos Yokohama Fenders. The repairs that need to be carried out on each fender (length of each fender is 6.5 mtrs and dia 3.5 mtrs) is as follows.

Yokohama Fender VPT No.1

1. Chain to be renewed 22 mm dia : 120 mtrs.(VPT supply)
2. 22mm shackles to be renewed: 90nos. (VPT supply)
3. 1no relief valve to be renewed.
4. 1no filling valve to be renewed.
5. Rubber sleeves to be renewed: 150nos
6. Patch work 20 sq.mtrs.
7. Bull rings to be renewed 20 nos.(VPT supply)
8. Small tyres to be renewed: 8nos.
9. Big tyres to be renewed: 32nos.

Yokohama Fender VPT No.3

1. Chains to be renewed 22 mm dia : 120 mtrs. (VPT supply)
2. 22mm shackles to be renewed: 100nos. (VPT supply)
3. 1no relief valve to be overhauled.
4. 1no filling valve to be overhauled.
5. Rubber sleeves to be renewed: 150nos.
6. Patch work 20 sq.mtrs.

7. Bull rings to be renewed : 20nos(VPT supply)
8. Big tyres to be renewed : 32nos
9. Small tyres to be renewed : 08nos

Yokohama Fender VPT No.5

1. Chain to be renewed, 22 mm dia : 120mtrs. .(VPT supply)
2. 22mm shackles to be renewed: 80nos (VPT supply)
3. 1no relief valve to be overhauled.
4. 1no filling valve to be overhauled.
5. Rubber sleeves to be renewed: 150nos
6. Bull rings to be renewed: 15 nos(VPT supply)
7. Big tyres to be renewed: 32nos
8. Small tyres to be renewed: 08nos.
9. Patch work 08 sq.mtrs.

Time Frame : - The interested firms shall submit their budgetary offers on or before 15.09.2018, to Harbour Master, Visakhapatnam Port Trust, Visakhapatnam 530001.
