6. Quoted price should be free from corrections / erasures. In case there is any unavoidable correction, it should be properly attested. If not the quotation will not be considered.
7. The quotations must be in the form furnished by the Port Trust.
8. The Port Trust reserves the right to modify the quantity specified in this enquiry
9. The consolidated L-I offer in the Tender will be considered for the acceptance for the negotiation and implementation of the repair work.
