CIRCULAR No. 986

Sub: - Review of Productivity Norms for tanker vessels calling at VPT – Reg.

Ref: - Board Resolution No.191/2018-19 in respect of Agenda item
No.S-35 of the Board meeting No.4 of 2018-19 of the Board of Trustees
of Visakhapatnam Port held on 21.02.2019.

As per Board Resolution No. 191/2018-19 Dt. 21.02.2019 under reference cited, Board resolved to approve implementation of the method of the calculation for the purpose of levying penalty for vessels carrying liquid cargo as follows:

1. In case of vessels carrying multiple commodities, the existing bench mark/ existing norms will be levied proportionately based on the tonnage carried by the respective cargoes and not on the volume for the largest parcel size in the event of the vessel fails to achieve the target norms.
2. Further, it was resolved to consider allowing pigging time of 2 hours interim period between handling of different cargoes when more than one cargo is handled through the same pipeline from the vessel carrying multiple commodities. The allowance in pigging time, as stated will be excluded from the total admissible time for loading/discharge, while computing the productivity norms of the vessel and the above method of calculation will be allowed only when multiple cargoes are handled beyond existing capacity of pipelines.

The above circular will come into implementation from the date of Board's approval i.e. 21.02.2019.
