It is to inform all the concerned that one more HMC of M/s Seapol has been received at this Port and is positioned at West Quay Berths.

VPT Board vide Resolution No. 192/2016-17 has resolved to approve the following:

1. To make the usage of HMC located at EQ-7 berth as mandatory for bulk cargo operations whenever any vessel is berthed at EQ-7 berth.
And
2. After the 2nd HMC is commissioned at WQ berths, they may be positioned at two suitable berths (as may be decided by the Chairman from time to time) and make the usage of the respective HMCs mandatory for bulk cargo operations whenever any vessel is berthed at those berths with HMC.

Thus, in pursuance to the VPT Board Resolution No. 192/2016-17, presently one HMC shall be located at WQ-1 berth and the other HMC would be located at WQ3 berth (Change of the location, if necessary will be as per the above Board Resolution). Usage of HMC for vessels berthing at WQ-1 and WQ-3 is made mandatory for bulk cargo operations. Vessels which intend to work with Ship Gear shall be berthed at WQ2, WQ4 and WQ5 only.
