Contract personnel will be paid monthly consolidated remuneration of Rs.25000/- PM (Income Tax as Applicable).

PERIOD OF ENGAGEMENT:

Contract personnel will be engaged initially for a period of one year which may be further extendable for a period of 2 years i.e., 3 years maximum subjected to the performance of the personnel and continuation of the post thereon.

OTHER BENEFITS

- Contract personnel will be entitled to 12 days Casual leave
- Contract personnel will not be eligible for any allowance / Transportation/benefits / PRP / incentives other than those mentioned above.



IMPORTANT INFORMATION

- ➤ Candidate shall have all original testimonials for verification at the time of interview / joining if called for in support of Age, Qualifications and Experience.
- E-mail ID and Mobile number to be entered in application form is mandatory. In case a candidate does not have a valid personal e-mail ID, he/she should create his/her new e-mail ID before applying. Candidates are advised to keep the e-mail ID and Mobile number entered in the application form compulsorily active for at least one year. All future correspondence shall be made via E-mail and / or SMS only.

- All computations of Age and Post Qualification Experience etc., shall be made up to 30-09-2021. Date of issuance of final mark sheet shall be taken as the date of acquiring qualification.
