AGE: Should have completed minimum 14 (fourteen) years of age as on 31-12-2021.

RESERVATION: The reservation of training placements for the Scheduled Castes, Scheduled Tribes and Other Backward Classes is at a ratio of 1:8, 1:20 and 1:4 respectively on the basis of total number of placements in terms of Apprentices Act.1961.

MODE AND CRITERIA OF ENGAGEMENT OF APPRENTICES:

- d) Engagement of Trade Apprentices will be made purely on the merit basis of aggregate marks obtained by the candidates in ITI.
- e) Preference will be given to the children of VPT Employees in the ratio of 4:1:1 i.e 4 for VPT, 1 for CHD and 1 for Outsiders. Again out of the ratio 4 for the children of port employees the sub-ratio of 2:1:1 will be followed to the children of deceased employees / medically invalidated & superannuated employees / serving employees respectively.
- f) Those who are short-listed basing on merit of marks secured in the qualifying exams will only be called for certificates verification.
- g) The trades will be allotted to the candidates at the discretion of the Head of the Department.

TRAVEL EXPENSES : No TA / DA will be paid for attending certificate verification.

BOARDING/LODGING : No boarding or No lodging expenses are admissible


The Applications should apply for engagement of Trade Apprentices through On-line (<https://www.apprenticeshipindia.gov.in>)
