
The tenderer who wishes to upload the tender documents from the VPA tenders website (<https://etenders.gov.in>). The tenderer who wishes to upload the tender documents from the VPA website (<http://etenders.gov.in>) and meet the following criteria (i) Details of average annual turnover shall not be less than 100% of the estimated amount put to tender during the last 3 (three) years ending 31st March of the previous financial year, duly certified by the Chartered Accountant, (ii) proof of experience in similar nature of works i.e., Civil Works experience of having successfully completed Civil Works during last 7 years ending last day of month previous to the one in which applications are invited should be 3 (three) Civil Works completed each costing not less than the amount equal to 40% of the estimated cost (or) 2 (two) Civil Works completed each costing not less than 50% of the estimated cost (or) one Civil Works completed costing not less than 80% of the estimated cost.

The tenderers may keep a watch for further amendments if any at <https://etenders.gov.in>. before submitting the bids and any further clarifications can also obtained from CE's office VPA.

In case of any inconsistency between conditions in the document / amendments / corrigendum / clarifications, the decision of the Engineer-in-charge shall be final.

The signed tender documents that are uploaded online on VPA e-procurement website (<http://etenders.gov.in>) will only be considered for bid evaluation.

Note: (1) The bidders should be pay the Transaction Fee (non-refundable) and EMD shall be accepted only in online through etenders portal only. Further, the bidders shall upload the copy of the online transaction details with UTR No. along with the Technical bid documents failing which the bid shall be summarily rejected. (2) In case of the NSIC/MSME certificate submitted bidders, the eligibility for exemption of Transaction fee and EMD amount subject to fulfilling of tender condition. (3) Port will not accept the payment of transaction fee and EMD through Demand Draft/RTGS/NEFT/Net Banking etc., and will not be considered for bid evaluation.
