- The candidature of the candidate at all stages of the selection process shall be provisional in nature.

- Before applying, the candidate should ensure that he/she fulfils the eligibility criteria and other norms mentioned in this advertisement. Candidates not meeting the specified criteria including experience profile, wherever required, shall not be considered for selection.
- Applications in which the essential qualification/experience cannot be fully ascertained will be liable for rejection. Accordingly, it is the responsibility of the candidate to satisfy that he/she meets the eligibility criteria (as mentioned in this advertisement) fully before applying, to properly fill the application and provide necessary documents asked for. The candidate must possess qualifications recognized by the relevant statutory bodies like UGC/AICTE etc., Correspondence course in Diploma shall not be considered as recognised qualification as per AICTE norms.
