In context to the aforesaid subject it is to inform that in view of the recent grievances filed by the residence of Visakhapatnam with the National Green Tribunal (NGT), on account of the recent rise in pollution caused due to improper method of transportation of cargo carried out by the handling agents and their transporters from the port of Visakhapatnam and the neighboring ports, the NGT has constituted a joint committee comprising of representative of State PCB, Nuclear Fuel Complex, Hyderabad, Coastal Zone Management Authority (CZMA), AP and Collector, Visakhapatnam and has directed the committee to make the findings in this regard and submit its report within a period of one month.

Hence, in view of the above the undersigned desires to conduct a meeting virtually with all the port users and the stake holders on the subject issue so as to discuss the course of action and the immediate preventive measures to be undertaken for mitigating the aforesaid crisis.
