He/ She is responsible for planning, designing, constructing and maintaining railway tracks, bridges, signals and execution of all works related to track maintenance including relaying work, coordination with other departments for smooth and safe running of trains etc.

TERMS AND CONDITIONS


1. **Tenure of Engagement :** The tenure of engagement shall be for a period of 01 year which can be extended by another year.
2. He shall report to the Chief Engineer (HoD)
3. Income tax as applicable will be recovered from the consolidated remuneration as per extant rules.
4. He will be allowed 12 days casual leave for 01 year on pro-rata basis.
5. He should not leave the Head Quarter without prior permission.
6. **Termination:** If any situation arises to terminate the contract appointment, the Port reserves the right to terminate the contract appointment by giving one month's notice.
7. **Claim for permanent absorption:** The contract engagement shall not confer any right to lay claim for permanent absorption in the Port service against any post whatsoever.
8. **Settlement of Disputes:** In the event of any dispute arising out of this contract, the interpretation and decision of the Chairman, VPA will be final and binding.
9. He should make his own arrangements of Transport for attending and leaving the work area. No TA / DA will be paid to him.
10. He will maintain absolute integrity and devotion to duty and will be liable for penal action for misconduct or causing loss to Port property attributable to him during the period of his contract engagement.
11. If any situation arises to terminate the contract appointment, the VPA reserves the right to terminate the contract appointment by giving one month's notice. Further, VPA reserves the right to terminate the contract at any time on the ground of mis-conduct or otherwise, without any notice and without assigning any reason.
12. He has to give <sup>01</sup> ~~03~~ <sup>all</sup> (Three) months advance notice prior to leaving the contract engagement.
13. This contract engagement is purely on contract basis and will not confer any right to lay claim to permanent absorption in the Port service against any post whatsoever.
14. He will work under the Administration control of Chief Engineer, Visakhapatnam Port Authority / or any other higher official as required.
15. He has to attend to any other works allotted / directed by the Chief Engineer from time to time, depending upon the exigencies of work.
