The tenderer who wishes to participate shall upload the tender documents to the VPA Website (http://etenders.gov.in) and meet the following criteria. Details of average annual turnover shall not be less than 100% of Estimated amount put to tender during the last 3 (three) years ending 31st March of the previous financial year, duly certified by the Charted Accountant. Proof of experience in similar nature of works i.e., having successfully completed Works in **Supply, Testing, Commissioning and O&M of Pre-fabricated STP's** during last 7 years ending last day of month previous to the one in which applications are invited should be 3 (three) works of **Supply, Testing, Commissioning and O&M of Pre-fabricated STP's** completed each costing not less than the amount equal to 40 % of the estimated amount put to tender (or) 2 (two) works of **Supply, Testing, Commissioning and O&M of Pre-fabricated STP's** completed costing not less than 50% of the estimated amount put to tender. (or) one work of **Supply, Testing, Commissioning and O&M of Pre-fabricated STP's** completed costing not less than 50% of the estimated amount put to tender. (or) one work of **Supply, Testing, Commissioning and O&M of Pre-fabricated STP's** completed costing not less than 50% of the estimated amount put to tender. (or) one work of **Supply, Testing, Commissioning and O&M of Pre-fabricated STP's** completed costing not less than 50% of the estimated amount put to tender. (or) one work of **Supply, Testing, Commissioning and O&M of Pre-fabricated STP's** completed costing not less than 80% of the estimated amount put to tender. Proof of Registration as a registered contractor with Govt./PSU or with VPA or other organization is not to be treated as an eligibility criteria.

In case of any inconsistency between conditions in the document/ amendments/ corrigendum/ clarifications, the decision of the Engineer-in-charge shall be final.

<u>Note</u>: (1) The bidders should pay the Transaction Fee (non-refundable) and EMD only in online through e tenders portal only. Further, the bidders shall upload the copy of the online transaction details along with the Technical bid documents failing which the bid shall be summarily rejected. (2) In case of the NSIC/MSME certificate submitted bidders, the eligibility for exemption of Transaction fee and EMD amount subject to fulfilling of tender condition.
