Sub: CARRYING PASSES/IDs PROOFS AND CHECKING & FRISKING AT ALL
THE ENTRY/EXIT POINTS – REG.

Ref: CISF Ir. No. E-42099/CISF/VPT/Mge. Cor/P.A/2016, dt. 12.7.20165

Vide referred letter, Commandant, CISF has informed that, Visakhapatnam Port Trust is one of the most sensitive ports of our country, especially because of its national importance and its location. The location of Eastern Naval Command and HSL, inside the port channel makes it more vulnerable from security point of view. Keeping in view of the sensitivity threat perception and to strengthen the security of this port, the following are to be complied with by all concerned to have a check and to permit only authorised entries.

1. Displaying of Identity Proof/Card/Pass by employees/workers and show the same to CISF personnel on duty, while entering into all protected areas.
2. Carry any original ID proof issued by authorised Govt. Authorities.
3. If it is not possible to carry original ID proofs, due to obvious reasons, they can carry the coloured Xerox of the original ID's dually vetted by CISF authority as advised by the Chairman/VPT.
4. It is requested to Co-Operate with CISF personnel on duty, at the time of entry / exist.

Hence, as proposed by the CISF Unit, VPT, all concerned are requested to take notice and strictly adhere to the above instructions.

With reference to the letter cited, it is to inform that, as per the guidelines of the
Bureau of Immigration, Ministry of Home Affairs, Govt. Of India, New Delhi, the family
members of the crew will be allowed for short stay during day time only.

1. The family members will be allowed for short stay, on the strength of shore
pass issued by the Immigration Authorities only.
2. No family member(s) will be allowed on the strength of authorisation issued
by the Master of the vessel / Shipping agent
