With reference to the subject cited above , it is to inform to all the Trade concerned that vide referene cited TAMP had approved quinquennium rate of 2013-18 and notified in the Gazette of India, Extraordinary Vide G.No. 469, dated 27.12.2016 for the categories such as Residential /Commercial/Industrial/Open Space unpaved/Paved / Covered Storage Sheds/Ware houses) Way leave Charges etc., of VPT Lands (11 Zones).

Further, as per the Annexure.II Schedule IA& IB of the said order the quinquennium rates have been revised w.e.f March 2013 and the same rates being collected for allied activities such as Bins, hoppers, garages, truck parking , weighbridges and other non cargo allotments as per the Circular No. 482 .

In this regard the collection of charges for the revised rates will be implemented w.e.f 1.4.2013 and differential bills for the above period will be raised and sent in due course!
