
This is to notify to all Shipping agents that they shall ensure to submit the berthing request through BERMAN in PCS as it was made mandatory.

It is observed that some of the agents are not filling in BERMAN and some of the agents filled the BERMAN in advance even when the vessel is not ready.

In this regard, it is to inform that the filing of BERMAN is compulsory and without BERMAN no berth allotment can be made. Further to intimate that the Trade must ensure that the vessel berthing details are filled based on BERMAN in PCS only when the vessel is ready in all aspects or else the berthing of the vessel cannot be taken place.

As such it is requested to all shipping agents to submit the vessel berthing details in PCS based on BERMAN, which enable us to calculate real time Turn round time of the vessels based on BERMAN.
