
Sub: By passing of cargo vehicles from usage of mechanical Truck Tyre Washing Facility at B-ramp of port connectivity road In port area- Reg.
Ref: Chief Engineer's Ir. No. IENG/EE(ENV)/TTW/42/Pt.II/722, dt.26.9.2017.

Vide reference cited, it was informed that some of the cargo vehicles are bypassing the usage of Truck Tyre Washing Facility provided at B-ramp of port connectivity Road in Port area, which is basically provided to ensure that the cargo vehicles passing through the "B" ramp are tyre washed properly so as to mitigate the dust pollution issue. However, due to Non-availing of the facility so provided, the basic purpose is being defeated and the efforts put up by the VPT in dust mitigation are not complied in Toto. Hence, in order to ensure compulsory usage of Truck Tyre Washing Facility at B-ramp for each and every cargo vehicle passing through the "B" ramp, it is advisable that the concerned are sensitized for compulsory usage. It may also be noted that in earlier occasions also the issue was brought out and the concerned firms whose vehicles have by passed the usage of the Truck Tyre Washing Facility was informed individually. It is regretted to inform that the incidents are still continuing. It is not out of the place to mention that record of the such By passed vehicles are being maintained and if the recurrence of the incidence (by passing) is regular, necessary action for non-issuance of vehicle permits will be initiated against the defaulting firms.

Hence, it is requested to all the concerned that all the Transporters in charge/Supervisors/ Drivers and all concerned are sensitized about the requirement of the compulsory usage of the Truck Tyre Washing Facility at B-ramp to avoid any action as mentioned above, in order to ensure compliance of the requirements under Pollution Control measures and to create dust Free Port environment.
