Sub: SOP for handling vessel in the Visakhapatnam Port - Reg Ref: Marine Department Note No. IMAR/N/2018 Dt. 17.10.2018

This is to notify to the Trade that the SOP for handling vessels in the Visakhapatnam port is as follows.

- 1.Sailing of Ammonia tanker with cargo on-board during dark hours from Fertilizer Berth will be handled by one Pilot ( Previously being handled by two pilots)
- 2.Berthing of Ammonia vessels during dark hours to Fertilizer Berth is permitted hence forth (restricted previously to day light hours)
- 3.Handling of Loaded cape size vessels to VGCB: At present, no loaded cape size vessels are berthed in dark hours. It is now decided to berth Cape-size vessels to VGCB/OB-I/OB-II with a draft of 14.5mtrs even during dark hours with four 50 Ton Bollard pull tugs.
- 4.Pilot is not required for the bunker barge movements with in BBI, BB-II, BB-III and from NBJ to Naval jetties and from Naval jetties to NBJ but the movements have to be fed in POS by the Port Control.
- 5. Vessels with LOA above 195.0mtrs or Beam over 32.00 mts shall be handled by two Pilots at all times to and from inner harbour.
- 6. For further clarification the following were also discussed.
  - •Night time for the purpose of allowances approved by wage Board is from 22.00hrs to 06.00hrs
  - Dark hours for the purpose of special honorarium approved by VPT board is from 1800 hrs to 0600 hrs.
  - •Dark hours for the purpose of Pilot boarding is from 1800hrs to 05.59hrs

#### 7. Allowance for on-poard Pilot at SPM

- a.OSD& other allowances are payable as per staff schedule for berthing &Un-berthing.
- b.Pilot on SPM watch keeping to be paid as per staff schedule for the duration of stay on board from the time the vessel is secured at SPM to the 2<sup>nd</sup> Pilot on Board time for un-berthing

### 8.SPM MOORING MASTER/UN-MOORING MASTER

a Mooring/Un-mooring Master shall continue to be paid applicable OSD with other allowances for the pilotage act as per staff schedule in addition Mooring Master fee as per staff schedule.
