- 6) The details of the applicant may clearly be mentioned alongwith length of service in the feeder grade posts and details of pay scales.
- 7) It may clearly be mentioned whether the candidate has experience in the feeder grade posts in regular or Adhoc or deputation basis.
- 8) The applications of non eligible candidates (i.e., who are not in the feeder grade posts) may not be forwarded.
- 9) Three copies of recent passport size photographs.
