Sub: Grant of License for Supply, installation, Commissioning, Operation and Maintenance of 1 (one) No. of Harbour Mobile Crane of capacity not less than the 100 MT and not more than (6) six years old, as on the date of submission of technical bid /tender, for a period of 05 (five) years extendable 02 (two) more years subject at the discretion of VPT and if the HMC is New is for a period of 05(five) years to the discretion of VPT for deployment in the Inner Harbour of Visakhapatnam Port Trust – Reg

Secretary & Attorney of the Board vide reference 1st cited informed that, subject work was awarded to M/s. TRS Lift & Shift Services Pvt. Ltd., and accordingly it was informed that the subject HMC was installed at West Quay – 7 Berth by M/s. TRS Lift & Shift Services Pvt.Ltd., Kolkata vide circular No. 974 and commercial operations also commenced recently.

It was also requested to all Port users vide circular No. 974 to utilize the Harbour Mobile Crane for their cargo handling operations at WQ-7 Berth only.

Subsequently all Port Users were informed vide circular No. 985, that the HMC can be utilized at both the berths i.e., WQ-7 & WQ-8 berths as communicated vide reference 3rd cited.

Now, with regard to the mandatory usage of HMC by Port Users when the vessels are berthed at WQ-7 & 8 berth, it is to state that usage of HMC is mandatory when the HMC is available and not allotted at another berth. Moreover, when the HMC is engaged for handling of cargo at any of the two berths WQ-7 & WQ-8, the Stevedore of the other vessel operating at the other berth WQ-7 & WQ-8 can use the ship crane for cargo handling operations.

Hence the said circular supersedes the earlier Circular No. 974, dt. 30.1.2019 and circular No. 985 dt. 16.3.2019.
