In continuation to this office circulars No. 913, dt. 16.7.2018 , 946, dt. 31.10.2018, and 996, dt.02.04.2019 wherein, it is circulated that The Ministry of Shipping (MOS) vide its letter No.PD-14033/34/2017-PD-V dated 4.7.2018 had conveyed TAMP orders dt. 8.6.2018 that an amount of 145/- per container will be levied on all containers (except transshipment and coastal) handled at the Major Port Trusts and terminals operating there in towards Mandatory User Charge (MUC) for the Logistics Data Bank (LDB) service to be rendered by DMICDC shall come into effect from the date of notification of the order passed in the Gazette of India and shall remain valid till 30th June 2019.

Further to the above, TAMP vide its letter dt. 25.06.2019 under reference 7th cited, extended the validity of the existing tariff for levy of MUC extended upto 30 September 2019 or till the effective date of implementation of new tariff to be fixed for levy of MUC based on the proposal filed by DMICDC, whichever is earlier.
