

TERMS & CONDITIONS APPLICABLE FOR THE POST OF SR.SIGNALMAN APPOINTED ON CONTRACT BASIS IN MARINE DEPARTMENT, VISAKHAPATNAM PORT TRUST, VISAKHAPATNAM

1. The Senior Signalman should work at Signal Station (Fishing Harbour) or elsewhere in port area under the administrative control of Deputy Conservator, Visakhapatnam
2. He will attend on all working days including Sundays and Holidays and in case of emergency on full time basis.
3. Prior permission should be obtained from the competent authority for late coming. In the event of absence, the remuneration will be paid on pro-rata basis, for the actual days of working.
4. If absent for more than 03 days without prior permission, his services will be terminated without any notice.
5. If absent for more than 03 days on medical grounds, a sick certificate from Government Medical Practitioner must be submitted.
6. He will not be entitled to any benefits except the consolidated remuneration prescribed. However, he will be paid for the extra hours done, beyond normal working hours on single hourly rate basis.
7. He will not be allowed to have any direct dealings with the employees.
8. His services are liable to be terminated on one-month notice without assigning any reason. VPT has got every right to rescind the contract at any time without assigning any reason.
9. This temporary engagement is strictly on contract basis, which does not confer any right for claiming any appointment for any post in the Port Trust in future.
10. The terms of appointment of Senior Signalman are initially for a period of three months from the date of taking the appointment. In case of necessity fresh appointment on contract basis for a further period may be considered on terms and conditions that will be indicated by the Port.
11. The senior Signalman should make his own arrangements of transport for attending and leaving the work spot at the schedule time as decided by the competent authority.
12. He shall attend to any other works that may be allotted by the Deputy Conservator from time to time.
13. Any other conditions which are considered necessary will be inserted by VPT by serving a notice to the Senior Signalman in order to meet the requirements of the exigencies during the contract period.
14. For any disputes arising out of and during the contract period between Visakhapatnam Port Trust and Senior Signalman, the same shall be referred to Chairman / VPT whose decision is final and binding.
15. The V.P.E. (temporary) Regulations 1991 w.e.f 26.07.1991 shall not be made applicable in the case of senior Signalman appointed on contract basis as per para 3 (1) of the said Regulations.
