- 2. E.M.D. Exemption The Bidders those who are claiming EMD exemption as per Ministry of Finance Guidelines dt. 12.11.2020 are advised to submit "Bid Security Declaration" towards EMD and the same should reach this office on or before opening of technical bid failing which the bid shall be summarily rejected.
- 3. The Bidder those who are claiming EMD exemption under NSIC/MSME has to submit the self-certified copy of the Registration Certificate issued by NSIC / Ministry of MSME for the works / services relevant to the subject works. The above Registration certificate should have validity on the date of opening of the technical bid.
- 4. Copy of "Application for obtaining NSIC/ MSME Registration" or pending renewal of NSIC/MSME certificates will not be entertained. Such offers will be treated as Offers received without Tender document cost.
- 5. Solvency: Firm has to submit solvency certificate from a nationalized Bank / Scheduled Bank to the extent of Rs. 75 (seventy five) thousand obtained within last one year from the date of opening of the tender.

(The firms, who are not complying with any one of the above criteria, their tender will be summarily rejected)All the eligible Bidders, who are registered with NSIC/Ministry of MSME are exempted from payment of Tender Document Cost subject to submission of Valid NSIC/MSME Certificate and request letter for exemption of Tender Cost)

Terms & Conditions:

- 1. Firms who are willing to participate in the tender shall have the previous experience in execution of the similar works i.e., "Supply, Installation, testing and commissioning of Generators/Maintenance of Generator/AMC's of Generators" works in Govt. Depts/Ports/PSU'S or any private and firm should submit the proof of the same along with their tender.
- 2. The Tenders must submit the tender in one Sealed Cover containing two separate sealed covers and these two covers shall be super scribed as "Cover-I and Cover-II" respectively.
- 3. All the covers shall be addressed to Superintendent Engineer (MECH), Visakhapatnam Port Trust, and Visakhapatnam 530 035 and sealed properly. Names and addresses of the tenderer shall also be written on all the covers.
- 4. The tenderer shall clearly write on <u>Cover-I (Technical Bid)</u> Tender for the work of "Dismantling, shifting, Installation, testing and commissioning of old 320 KVA Generators with Acoustic enclosure from AOB to LPG Berth Sub-Station Generators room ". <u>On Cover-II (Price Bid)</u> - Tender for the work of " Dismantling, shifting, Installation, testing and commissioning of old 320 KVA Generators with Acoustic enclosure from AOB to LPG Berth Sub-Station Generators room ".

The main cover containing Cover-I, Cover-II along with the attached cover containing Tender document Cost and to submit "Bid Security Declaration" towards EMD exemption as per Ministry of Finance Guidelines dt. 12.11.2020 shall reach Superintendent Engineer (MECH), Visakhapatnam Port Trust, Visakhapatnam - 530 035 within the schedule date and time.

- 5. Firm's quoted rate shall be exclusive of GST.
- 6. Validity of offer should be <u>03 months</u> from the date of receipt of the quotations.
- 7. The firm shall submit copies of executed work orders in Govt. / Private Firms in proof of their experience in executing similar works in the last seven years. Similar works shall mean experience in "Supply, Installation, testing and commissioning of Generators/Maintenance of Generator/AMC's of Generators".
- 8. Conditional offers will be rejected.

- 10. The tenders received without complying with any of the above points is liable for rejection without assigning any reason.
- 11. The offer of the firm is liable for rejection in case of past poor performance record with VPT i.e. Quality, Delivery etc.,
- 12. Tender is to be submitted in a sealed cover duly super scribing the name of work and addressed to the S.E(M), Visakhapatnam Port Trust, Visakhapatnam..
- 13. Work completion period should be <u>**15 days**</u> from the date of site clearance.
- 14. The work shall be completed within the stipulated period, failing which a penalty @ 1/2% will be levied for every week of delay, on the part of the contractor subject to maximum 10% on total contract / executed value.
- 15. In case work is delayed beyond reasonable time, VPT at its discretion will confiscate and the work will be executed at the cost, risks & responsibility of the contractor apart from initiating legal action as per the extant rules.
- 16. Firm has to mobilize the required men, tools, tackles, materials and consumables for completion of the subject work immediately after issue of site clearance for execution of the subject work.
- 17. Safety Measures: The contractor is responsible for taking precautionary measures for the safety of lives of men working under him and the responsibility arising due to any mishap during execution of the work, the payment of any compensation etc. lies entirely on the part of the contractor
